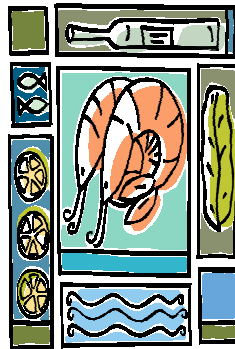

WI-FI UPDATE

With the advent of summer upon us we will be experiencing more and more traffic on our wifi system in the community. We have upgraded the system to attempt to serve the residents as best as possible but when everyone is down here and logged on the system will slow down dramatically. If you require HIGH speed please go to the Clubhouse and log in to one of 3 antennae's Assateague Point and Assateague Point5G inside and Asst-Pointe 5-1 outside. At the Rec center use Asst-Point2.4G and Asst-Point5G-7-1 inside and Asst-Point 6-1 and Asst-Point 9-1 outside. These are the 2 locations that will provide the best wifi service in the community. If you require better service than this you will need to subscribe to Comcast at your home.

Dear Homeowners:

It has been brought to the board's attention again about the cat's in the community. Joe McGee, president of the Association, has met with Animal control and has been informed that if someone is feeding a feral cat for more than 15 days, they are no longer feral and you are the responsible party for any and all damages incurred by the cat. This can include golf cart seat damage, fleas infesting a home they have been living under, and gardens of neighbors that the cats have used for a litter box.

By feeding these cats outside, they can not be trapped because they have been fed by someone. You also are feeding other wild life, such as raccoons or fox that could be carrying rabies which might be dangerous to the community as a whole.

This can not be tolerated. The board has decided that after June 15, all loose cats will be trapped. Also this will be looked at as a community nuisance and a fineable offense.

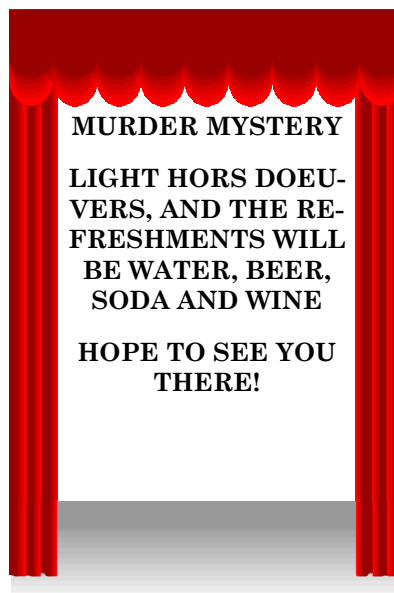

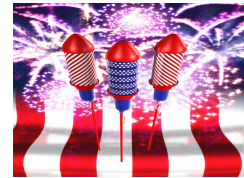
