- 1) Pools- Pools will remain open until September 24Th. After Labor Day it will be swim at your own risk, there will be no lifeguards on duty. On pool closing day we will have a dog swim at the Rec. Center pool from 3-6 PM. Bring your Furry friend and have some fun. If you have a problem or complaint, please do not confront the lifeguards, contact the front office and we will resolve the issue.
- 2) Activities- We still have many activities on the schedule including Crab Feast, Farewell to Summer Party and Children's Halloween Party. Thanks to all the volunteers who make these wonderful events possible.
- 3) Trash- If you see that the center dumpster is full, please use the side dumpster by the tree that is usually empty. When the trash is piled up over the top of the dumpster Waste Management will not remove it, but we are still charged for the visit. If you know in advance that you will have a lot of bulk items from a project please notify the front office. Thanks for your cooperation

Everything is doing good, but the extreme heat is taking a toll on some of the gardens. The new Crepe Myrtle trees are looking good and a few are starting to bloom.

If you see any of gardens or flower pots by the front gates are looking dry and droopy please feel free to give them a drink of water.

#### Pools Report-Barry King

Due to high temperatures this summer the pools have seen a lot of activity. Along with the high temperatures the winds have been high as well. The wind has damaged about 8 umbrellas even with them closed. These damaged umbrellas were removed and replaced with spares umbrellas. There were no injuries on either of the pool decks when this occurred. There has been some breakage of pool furniture as well and an inventory will be taken at the end of the season and replacement furniture will be ordered for next year.

We are still experiencing people bringing glass products onto the pool decks.

I really don't want to sound like a broken record but glass products do NOT belong on the pool decks even in coolers! Most people think that they will not break their glass product! But it only takes one breakage on either pool deck to close the pool. One breakage means the pool has to be drained, power washed and refilled and then inspected by the Dept. of Health. This means that the pool with breakage will be closed for at least a week. With the volume of people at AP on any given week, and only one pool being open, that one pool will NOT be able to handle the volume of people. If you see any one with glass on the pool deck, please report the violator to the life guard immediately. If you rent your property, please let your tenants know that glass items are not allowed on the pool's decks at any time! All entrances to the pools as well as the pool decks have signs stating NO GLASS is allowed.

The pools will be open with life guards until September 5. The pools will close September 24. Don't forget the Dog Swim Day is September 24 from 3 to 6 at the Rec. Center pool only. The Rec. Center pool will close immediately after the dog swim.

The Pointe is looking great, thank you all for taking pride in your properties and making AP the place to be in OC.

A few friendly reminders...

- Please make sure all golf carts have updated registration stickers and visible lot numbers. If your golf cart does not have a AP registration sticker, please go to front office and Xanthe will get you one.
- Wood burning fire pits are NOT allowed within the community. Propane fire pits are the ONLY fire pits allowed.
- Remember to have an approved ECC form before any outside work on your home is completed.

#### Storage Yard- Joyce Wetzel

I have completed a "first sweep" of the storage yard and have placed stickers where I could. I still have a stack that I will turn in once I finalize my list and do a second sweep to see if any additional stickers can be placed. I have come across a couple issues, and some of these may change once I do my second sweep but for now, this is what I have observed: While some slots are cleaner than others, every slot could use a little weed maintenance. I will be forwarding information to MaryAnn regarding those that need letters forwarded.

In the last Newsletter, I gave you a formula for an inexpensive DIY solution that will kill the weeds or they are sold at your local Home Depot, Walmart, Hardware stores, etc. There are also several companies that can help you. Contact the office for names and numbers. STORAGE YARD RULES state you must control weeds and remove all debris on you slot.

Also, there are several instances where what is in the slot does not match what was registered to be there. If that was the case, I did not give you a 2022 sticker. Your registration form must reflect what is in your slot. If what you have registered to be in your slot changes during the year, you need to update your registration paper. There are still a few who have not yet filled out their registration form. If a violation is issued and not taken care of in 30 days, you will be asked to remove you items from the storage yard and you will lose your slot privileges. All violations must be taken care of by December 31st or slots will not be renewed.

ABSOLUTELY NO RENTERS WILL BE ALLOWED TO USE THE STORAGE YARD FACILITY. There was a renter this week that parked his trailer and boat in the center of the yard. When I approached him, he indicated he had been a long-time renter and was given permission.
